## **PRESIDENT MACRON INAUGURATES JP MORGAN NEW OFFICES IN PARIS WITH CEO JAMIE DIMON**

### **3,000 JOBS CREATION BY END OF 2021**

**USPA NEWS** - As part of the 4th edition of the "Choose France" summit, the French President Macron inaugurated the new Parisian offices of JP Morgan in Paris, on Tuesday June 29, 2021, in the presence of Bruno Lemaire, Minister of the Economy, Finance and Recovery, and Mr. Jamie Dimon, Chairman and CEO of JP Morgan. JP Morgan, the world's leading investment bank, has chosen Paris as its European hub for market activities. During this visit, the Head of State notably met members of multinational trading room teams who have joined Paris. The French Head of State, Emmanuel Macron, who happened to be a former investment banker at Rothschild, even before becoming a young minister of economics and finance in 2016, visited the bank's new trading room, where transactions of hundreds of billions of euros are carried out on French and European debts. JP Morgan has decided to repatriate several hundred traders from London, because since Brexit some operations can no longer be done from London. The American bank will thus increase its Parisian workforce from 265 pre-Brexit to 700 at the end of 2021 then 800 at the end of 2022, its leaders said

The City of London remains its main center in the region with 19,000 jobs. Overall, 3,000 new jobs will be created in finance in France by the end of 2021 compared to the pre-Brexit situation. "Mr. President, dear Emmanuel, I met you when you were Minister of the Economy, you asked me if it would be possible to transfer part of our market activities to France as part of Brexit. Ma The response was scathing: mission impossible with a president for whom finance is the first enemy, "the president of JP Morgan France, Kyril Courboin, told him. Yet, he continued, a new president has arrived, "this young banker full of passion who wanted to change France" and whose new Minister of the Economy Bruno Le Maire "told us + if you have a problem we will find a solution + ". Same enthusiasm with the CEO of JP Morgan, Jamie Dimon, who paid tribute to a president "coherent, solid" for the business world.-----

The second news, realizing an old dream of the French Head of State (former investment banker), announces the inauguration of the new headquarters of the American Leader Private Bank of Business, JP Morgan, in Paris, Place Vendôme. The inauguration by President Macron and Jamie Dimon CEO of JP Morgan, and in the presence of the Minister of Economy and Finance Bruno Lemaire took place on Tuesday morning, 29 June.-----

By the end of 2022, the company's various offices in the capital will accommodate a total of 800 people. Across the world, the workforce is around 260,000 people. According to the Elysée, 3,000 jobs will be created before the end of the year, and 1,000 additional recruitments will be made in 2022. The Minister of the Economy Bruno Lemaire welcomed this centralisation of banking and trading operation in the French Capital : "This is a strategic choice that we have made and implemented over the past four years. We wanted to make France a major financial center in Europe. »
